5. The Applicants and any parties or intervenors in support of the applications are to file and serve any reply on all other parties and intervenors for whom appearances have been entered by 4.00 p.m. on Tuesday 28 July 2009.
6. Each party and/or intervenor opposing the applications are to file and serve on the applicants and all other parties or intervenors for whom appearances have been entered, any material in response to the applicants' reply and in response to the Queensland Government's submissions by 4.00 p.m. on Thursday 30 July 2009.
