**Reasons for Decision**

- [1] The Townsville City Council has applied to terminate the *Townsville City Council (Queensland Local Government Officers) Certified Agreement 2012*, it does so pursuant to s 228(1) of the *Industrial Relations Act 2016*.
- [2] The certified agreement had a nominal expiry date of 1 April 2015.
- [3] On the basis that the agreement does not include any provisions recording that any particular conditions need to be met before it may be terminated;<sup>1</sup> that the Commission is satisfied that the Townsville City Council has given notice of its intention to apply to terminate the agreement;<sup>2</sup> that the other parties to the agreement agree to it being terminated;<sup>3</sup> and, that the termination of the determination is not contrary to the public interest;<sup>4</sup> the *Townsville City Council (Queensland Local Government Officers) Certified Agreement 2012* is terminated as from 15 March 2018.<sup>5</sup>
- [4] I make the following order:
- 1. The *Townsville City Council (Queensland Local Government Officers) Certified Agreement 2012* is terminated.**
