Reasons for Decision

- [1] The Quilpie Shire Council has applied to terminate the *Quilpie Shire Council, Administration, Community Services, Environmental Services and Technical Stream, Certified Agreement 2012* and the *Quilpie Shire Council Certified Agreement 2012-2015*, it does so pursuant to s 228(1) of the *Industrial Relations Act 2016*.
- [2] Both certified agreements had a nominal expiry date of 11 November 2015.
- [3] On the basis that the agreement does not include any provisions recording that any particular conditions need to be met before it may be terminated;¹ that the Commission is satisfied that the Quilpe Shire Council has given notice of its intention to apply to terminate the agreement;² that the other parties to the agreement agree to it being terminated;³ and, that the termination of the determination is not contrary to the public interest;⁴ the *Quilpie Shire Council, Administration, Community Services, Environmental Services and Technical Stream, Certified Agreement 2012* and the *Quilpie Shire Council Certified Agreement 2012-2015*, is terminated as from 11 May 2018.⁵
- [4] I make the following order:

- 1. The *Quilpie Shire Council, Administration, Community Services, Environmental Services and Technical Stream, Certified Agreement 2012* is terminated.**
- 2. The *Quilpie Shire Council Certified Agreement 2012-2015* is terminated.**
