## **Reasons for Decision**

- [1] The Southern Downs Regional Council has applied to terminate the *Southern Downs Regional Council Employee Enterprise Bargaining Certified Agreement 2011-2014*, it does so pursuant to s 228(1) of the *Industrial Relations Act* 2016.
- [2] The certified agreement had a nominal expiry date of 30 June 2014.
- [3] On the basis that the agreement does not include any provisions recording that any particular conditions need to be met before it may be terminated;<sup>1</sup> that the Commission is satisfied that the Southern Downs Regional Council has given notice of its intention to apply to terminate the agreement;<sup>2</sup> that the other parties to the agreement agree to it being terminated;<sup>3</sup> and, that the termination of the agreement is not contrary to the public interest;<sup>4</sup> the *Southern Downs Regional Council Employee Enterprise Bargaining Certified Agreement 2011-2014* is terminated as and from 10 August 2018.<sup>5</sup>
- [4] I make the following order:
  - 1. The Southern Downs Regional Council Employee Enterprise Bargaining Certified Agreement 2011-2014 is terminated.
