Reasons for Decision

- [1] The Ipswich City Council has made an application to certify an agreement pursuant to s 189 of the *Industrial Relations Act* 2016. As required by s 189(3) of the Act, the application was made within 21 days of the date on which the agreement was made. The agreement is between the Ipswich City Council and the following employee organisations:
 - Transport Workers' Union of Australia, Union of Employees (Queensland Branch)
 - Plumbers & Gasfitters Employees' Union Queensland, Union of Employees

- The Australian Workers' Union of Employees, Queensland
- The Electrical Trades Union of Employees Queensland
- United Voice, Industrial Union of Employees, Queensland
- Construction, Forestry, Mining & Energy, Industrial Union of Employees, Queensland
- Automotive, Metals, Engineering, Printing and Kindred Industries Industrial Union of Employees, Queensland.
- [2] The agreement has been signed by all parties to the agreement¹ with the exception of The Electrical Trades Union of Employees Queensland (ETU) who provided correspondence to the effect:

The ETU agreed to the terms of the Agreement but does not intend to sign the Agreement. The ETU wishes to be a party to and covered by the agreement.

The parties to the agreement, present in the Commission, had no objection to the course embarked upon by the ETU.

- [3] The agreement is to apply to the Ipswich City Council and all of its employees for whom classifications and rates of pay are prescribed in the agreement.
- [4] In proceedings on 18 January 2019 the Commission as presently constituted certified the agreement.
- [5] In certifying the agreement, the Commission recognises that:² each relevant requirement under subdivision 2 of Division 2 of Part 5 of the Act has been satisfied;³ and, that there was nothing in the agreement which would require the Commission to refuse to grant the application under subdivision 3 of Division 2 of Part 5 of the Act.⁴
- [6] The agreement operates from the day it was certified, namely 18 January 2019.⁵ Although the nominal expiry date of the agreement is on 1 October 2021 the agreement continues to operate until it is terminated under s 227 or s 228 of the Act.
