## **Reasons for Decision**

[1] The Burdekin Shire Council has applied to terminate the *Burdekin Shire Council Enterprise Bargaining Certified Agreement 2012*, pursuant to s 228(1) of the *Industrial Relations Act* 2016.

- [2] The certified agreement had a nominal expiry date of 30 June 2015.
- [3] On the basis that the agreement does not include any provisions recording that any particular conditions need to be met before it may be terminated; that the Commission is satisfied that the Burdekin Shire Council has given notice of its intention to apply to terminate the agreement; that the other parties to the agreement agree to it being terminated; and, that the termination of the determination is not contrary to the public interest; the *Burdekin Shire Council Enterprise Bargaining Certified Agreement 2012*, is terminated as from 12 June 2018.
- [4] I make the following order:
  - 1. The Burdekin Shire Council Enterprise Bargaining Certified Agreement 2012 is terminated.
