Reasons for Decision

[1] The Lockyer Valley Regional Council has applied to terminate the *Lockyer Valley Regional Council Certified Agreement (Field Staff)* 2012 - CA/2012/39, pursuant to s 228(1) of the *Industrial Relations Act* 2016.

- [2] The certified agreement had a nominal expiry date of 22 July 2015.
- [3] On the basis that the agreement does not include any provisions recording that any particular conditions need to be met before it may be terminated; that the Commission is satisfied that the Lockyer Valley Regional Council has given notice of its intention to apply to terminate the agreement; that the other parties to the agreement agree to it being terminated; and, that the termination of the determination is not contrary to the public interest; the Lockyer Valley Regional Council Certified Agreement (Field Staff) 2012 CA/2012/39, is terminated as from 3 August 2018.
- [4] I make the following order:
 - 1. The Lockyer Valley Regional Council Certified Agreement (Field Staff) 2012 CA/2012/39 is terminated.
