## Reasons for Decision

- [1] On 5 November 2019, the Director-General of the Department of Transport and Main Roads applied, pursuant to s 228(1) of the *Industrial Relations Act 2016* ('the Act'), to terminate the *Maritime Safety Queensland Maritime Operations Certified Agreement 2015* ('the Agreement').
- [2] The Agreement has a nominal expiry date of 30 September 2018.
- [3] Section 228(3) of the Act provides:
  - (3) The commission must approve the termination if, and must refuse to approve the termination unless, satisfied subsection (2) has been complied with and -
    - (a) for an agreement or determination that provides that it may be terminated if particular conditions are met the conditions have been met; or
    - (b) for an agreement or determination that does not provide for the way it may be terminated -
      - (i) the other parties to the agreement or determination agree to it being terminated; and
      - (ii) termination of the agreement or determination is not contrary to the public interest.
- [4] The Agreement does not provide that particular conditions need to be met before it may be terminated.
- [5] Having regard to the affidavit of Mr Neil Scales filed 5 November 2019, I am satisfied that Department of Transport and Main Roads has given the requisite notice of its intention to apply to terminate the Agreement.
- [6] I have had regard to:
  - the submissions made by the parties who appeared today; and

- the affidavit of Neil Scales, Director-General of the Department of Transport and Main Roads dated 5 November 2019.
- [7] On 5 November 2019, the Director-General of the Department of Transport and Main Roads made an application, pursuant to s 189 of the Act, to certify the *Maritime Safety Queensland Maritime Operations Certified Agreement 2018*.
- [8] The Department of Transport and Main Roads and the following employee organisations have agreed to the terms of the *Maritime Safety Queensland Maritime Operations Certified Agreement 2018* which will replace the Agreement:
  - The Australian Maritime Officers Union Queensland Union of Employees;
  - The Electrical Trades Union of Employees, Queensland;
  - The Australian Workers' Union of Employees, Queensland;
  - The Australian Institute of Marine and Power Engineers' Union of Employees, Queensland District; and
  - Together Queensland, Industrial Union of Employees
- [9] I am satisfied that:
  - all parties to the Agreement agree to it being terminated; and
  - the termination of the Agreement is not contrary to the public interest.
- [10] Section 228(4) of the Act provides that termination takes effect when the Commission's approval takes effect.
- [11] I approve the termination of the *Maritime Safety Queensland Maritime Operations Certified Agreement 2015* with effect from 21 November 2019.
- [12] I make the following order:
  - 1. The Maritime Safety Queensland Maritime Operations Certified Agreement 2015 is terminated.
