## **Reasons for Decision**

- [1] The Department of Education has applied to terminate the *Department of Education and Training Teacher Aides' Certified Agreement 2015*, it does so pursuant to s 228(1) of the *Industrial Relations Act* 2016. The certified agreement had a nominal expiry date of 31 August 2018.
- [2] The application for termination contains an affidavit of Marie Creighton sworn 17 May 2019. Ms Creighton deposes that the Department executed a Form 50 Notice of intention to terminate a certified agreement on 16 May 2019; that the notice had been given to all persons to whom the agreement applies by special broadcast email from the Director-General of the Department of Education on 22 March 2019; and, that the termination is not contrary to the public interest.
- [3] On the basis that the agreement does not include any provisions recording that any particular conditions need to be met before it may be terminated; that the Commission is satisfied that the Department has given notice of its intention to apply to terminate the agreement; that the other parties to the agreement agree to it being terminated; and, that the termination of the determination is not contrary to the public interest; the Department of Education and Training Teacher Aides' Certified Agreement 2015, is terminated as from 11 June 2019.
- [4] I make the following order:
  - 1. The Department of Education and Training Teacher Aides' Certified Agreement 2015 is terminated.
