## **Reasons for Decision**

[1] The State of Queensland (Department of Housing and Public Works) has applied to terminate the *QFleet Certified Agreement 2016*. It does so pursuant to s 228(1) of the *Industrial Relations Act 2016*.

[2] The Agreement nominally expired on 31 August 2018 and the parties consent to its termination.

- [3] I have considered the affidavit of Ms. Elizabeth Therese Carroll, Director-General of the Department of Housing and Public Works, sworn 25 June 2019.
- [4] I am satisfied that:
  - the agreement does not provide any particular conditions that must be met before it may be terminated; 1
  - the Commission is satisfied that State of Queensland (Department of Housing and Public Works) has given notice of its intention to apply to terminate the agreement;<sup>2</sup>
  - the other parties to the agreement agree to its being terminated;<sup>3</sup> and
  - the termination of the agreement is not contrary to the public interest.<sup>4</sup>
- [5] On that basis, I terminate the *QFleet Certified Agreement 2016* with effect from 12 July 2019.<sup>5</sup>
- [6] I make the following order:
  - 1. The QFleet Certified Agreement 2016 is terminated.
