- ORDER: **1. The Cairns Regional Council Certified Agreement 2012 is terminated.**

Reasons for Decision

- [1] On 29 August 2019, the Cairns Regional Council applied, pursuant to s 228(1) of the *Industrial Relations Act 2016* ('the Act'), to terminate the *Cairns Regional Council Certified Agreement 2012* ('the certified agreement').
- [2] The certified agreement has a nominal expiry date of 17 September 2015.
- [3] Section 228(3) of the Act provides:
- (3) The commission must approve the termination if, and must refuse to approve the termination unless, satisfied subsection (2) has been complied with and -
 - (a) for an agreement or determination that provides that it may be terminated if particular conditions are met - the conditions have been met; or
 - (b) for an agreement or determination that does not provide for the way it may be terminated -
 - (i) the other parties to the agreement or determination agree to it being terminated; and
 - (ii) termination of the agreement or determination is not contrary to the public interest.
- [4] The certified agreement does not provide that particular conditions need to be met before it may be terminated.

[5] Having regard to the affidavits of Ms Christine Postgate filed 29 August 2019, I am satisfied that Cairns Regional Council has given the requisite notice of its intention to apply to terminate the certified agreement.

[6] I have had regard to:

- the submissions made by the parties who appeared today; and
- the affidavit of Ms Christine Postgate, General Manager Human Resources and Organisational change of Cairns Regional Council filed on 29 August 2019.

[7] On 29 August 2019, Cairns Regional Council made an application, pursuant to s 189 of the Act, to certify the *Cairns Regional Council Certified Agreement 2019*.

[8] Cairns Regional Council and the following employee organisations have agreed to the terms of the *Cairns Regional Council Union Collective Certified Agreement 2019* which will replace the certified agreement:

- Automotive, Metals, Engineering, Printing and Kindred Industries Industrial Union of Employees, Queensland
- Plumbers & Gasfitters Employees' Union Queensland, Union of Employees
- Queensland Services, Industrial Union of Employees
- The Association of Professional Engineers, Scientists and Managers, Australia, Queensland Branch, Union of Employees
- The Australian Workers' Union of Employees, Queensland
- The Construction, Forestry, Mining & Energy, Industrial Union of Employees, Queensland
- The Electrical Trades Union of Employees Queensland
- Transport Workers Union, Union of Employees (Queensland Branch)
- United Voice, Industrial Union of Employees, Queensland

[9] I am satisfied that:

- all parties to the certified agreement agree to it being terminated; and
- the termination of the certified agreement is not contrary to the public interest.

[10] Section 228(4) of the Act provides that termination takes effect when the Commission's approval takes effect.

[11] I approve the termination of the *Cairns Regional Council Certified Agreement 2012* with effect from 3 October 2019.

[12] I make the following order:

- 1. The *Cairns Regional Council Certified Agreement 2012* is terminated.**
