Reasons for Decision

- [1] Stadiums Queensland has made an application to certify an agreement pursuant to section 189 of the *Industrial Relations Act* 2016. As required by s 189(3) of the Act, the application was made within 21 days of the date on which the agreement was made. The agreement is between:
 - Stadiums Queensland (the "employer"); and
 - all employees employed by the employer (with the exception of staff on individual contracts and event day casuals); and
 - The Australian Workers' Union of Employees, Queensland; and
 - The Electrical Trades Union of Employees, Queensland; and
 - Together Queensland, Industrial Union of Employees; and
 - United Voice, Industrial Union of Employees, Queensland.
- [2] In proceedings on 9 June 2020 the Commission as presently constituted certified the agreement.
- [3] In certifying the agreement, the Commission recognises that: 1 each relevant requirement under subdivision 2 of Division 2 of Part 5 of the Act has been satisfied; 2 and, that there was nothing in the agreement which would require the Commission to refuse to grant the application under subdivision 3 of Division 2 of Part 5 of the Act. 3

- [4] The agreement operates from the day it was certified, namely 9 June 2020.⁴ Although the nominal expiry date of the agreement is 31 July 2023, the agreement continues to operate until it is terminated under s 227 or s 228 of the Act.
- [5] The application to certify the *Stadiums Queensland Staff Certified Agreement 2019* is granted.
- [6] I make the following order:
 - 1. The Stadiums Queensland Staff Certified Agreement 2019 is certified.
