## **Reasons for Decision**

On 29 September 2020, the Chief Executive Officer of the Cloncurry Shire Council [1] pursuant to s 189 of the Industrial Relations Act 2016 ('the Act'), made an application to certify the Cloncurry Shire Council Certified Agreement 2019 ('the Agreement').

- [2] The Agreement names the parties as being the Cloncurry Shire Council and the following employee organisations:
  - The Australian Workers' Union of Employees, Queensland; and
  - Queensland Services, Industrial Union of Employees
- [3] Clause 1.2 of the Agreement states it is binding on:
  - The Cloncurry Shire Council;
  - Its employees subject to the Agreement; and
  - The employee organisations named above at [2].
- [4] Having regard to the affidavit of David Jacobus Bezuidenhout which was filed 29 September 2020:
  - I am satisfied of each relevant requirement in ch 4, pt 5, div 2, sub-div 2 of the Act; and
  - There is nothing in the Agreement which would require me to refuse to grant the application pursuant to ch 4, pt 5, div 2, sub-div 3 of the Act.
- [5] The application to certify the *Cloncurry Shire Council Certified Agreement 2019* is granted.
- [6] The *Cloncurry Shire Council Certified Agreement 2019* operates from the day it is certified, namely 21 October 2020.
- [7] Although the nominal expiry date of the *Cloncurry Shire Council Certified Agreement* 2019 is 30 June 2022, it continues to operate until it is terminated under s 227 or s 228 of the Act.
- [8] I make the following order:
  - 1. The Cloncurry Shire Council Certified Agreement 2019 is certified.
