Reasons for Decision

- [1] On 16 December 2020, the Whitsunday Regional Council ("the applicant"), pursuant to s 189 of the Industrial Relations Act 2016 (Qld) ("the Act"), applied to certify the Whitsunday Regional Council Certified Agreement 2020 ("the agreement").
- [2] The named parties to the agreement are:
 - Whitsunday Regional Council;
 - The Australian Workers' Union of Employees, Queensland;
 - Construction, Forestry, Mining & Energy, Industrial Union of Employees, Queensland;
 - Automotive, Metals, Engineering, Printing and Kindred Industries Industrial Union of Employees, Queensland;
 - Plumbers & Gasfitters Employees' Union Queensland, Union of Employees
 - Queensland Services, Industrial Union of Employees; and
 - The Association of Professional Engineers, Scientists and Managers, Australia, Queensland Branch, Union of Employees
- [3] The agreement is signed by all the above-mentioned parties.
- [4] The agreement applies to the parties to the agreement listed in cl 1.2 and to the Applicant's employees for whom classifications and rates of pay are prescribed in the agreement.
- [5] The application is accompanied by a copy of the agreement signed by each party.
- [6] I have had regard to the affidavit of Mr Rod Ferguson, Chief Executive Officer for the Applicant, filed on 16 December 2020.
- [7] Having regard to the abovementioned affidavit:
 - I am satisfied of each relevant requirement in ch 4, pt 5, div 2, sub-div 2 of the Act; and
 - There is nothing in the agreement which would require me to refuse to grant the application pursuant to ch 4, pt 5, div 2, sub-div 3 of the Act.
- [8] The application to certify the *Whitsunday Regional Council Certified Agreement 2020* is granted.

- [9] The Whitsunday Regional Council Certified Agreement 2020 operates from the day it is certified, namely 8 February 2021.
- [10] Although the nominal expiry date of the *Whitsunday Regional Council Certified Agreement 2020* is 8 February 2022, it continues to operate until it is terminated under s 227 or s 228 of the Act.
- [11] I make the following order:

The Whitsunday Regional Council Certified Agreement 2020 is certified.
