Reasons for Decision

- [1] On 4 March 2020, the Chief Executive Officer of the Western Downs Regional Council ('the Applicant') pursuant to s 189 of the *Industrial Relations Act 2016* ('the Act'), made an application to certify the *Western Downs Regional Council Non-Operational Staff Certified Agreement 2020* ('the Agreement').
- [2] Clause 2.1 of the Agreement names the parties as the Applicant and the following employee organisations:
 - Queensland Services, Industrial Union of Employees; and
 - The Australian Workers' Union of Employees, Queensland.
- [3] The Agreement covers:
 - The Western Downs Regional Council,
 - its employees; and
 - the organisations named at cl. 2.1 of the Agreement.
- [4] Having regard to the submissions made by the parties who appeared and to the affidavit of Mr Ross Musgrove filed 4 March 2020:
 - I am satisfied of each relevant requirement in ch 4, pt 5, div 2, sub-div 2 of the Act; and
 - there is nothing in the Agreement which would require me to refuse to grant the application pursuant to ch 4, pt 5, div 2, sub-div 3 of the Act.
- [5] The application to certify the Western Downs Regional Council Non-Operational Staff Certified Agreement 2020 is granted.
- [6] The Western Downs Regional Council Non-Operational Staff Certified Agreement 2020 operates from the day it is certified, namely 26 March 2020.
- [7] Although the nominal expiry date of the *Western Downs Regional Council Non-Operational Staff Certified Agreement 2020* is 26 March 2023, it continues to operate until it is terminated under s 227 or s 228 of the Act.
- [8] I make the following order:
 - 1. The Western Downs Regional Council Non-Operational Staff Certified Agreement 2020 is certified.
