Aurizon was advised through WHS meetings as well as the internal hazard reporting system (Beakon) on 22/08/2023, 05/10/2023 & 08/10/2023 there was significant risks to rail workers whilst performing their duties within the rail corridor at Kinrola balloon. Overgrown vegetation within the corridor is at an unacceptable length for Aurizon employee's to perform their roles without a risk to their health and safety. The presence of feral pigs and snakes in this area also presents its own hazard to Aurizon employees who walk this area. The area in question is on a mining lease owned by Whitehaven which does not relieve Aurizon of their duty to consult with other duty holders in relation to the same matter Section 46 WHS Act.
