Reasons for Decision

- [1] On 15 July 2025, South Burnett Regional Council ('the Applicant'), pursuant to s 189 of the *Industrial Relations Act 2016* (Qld) ('IR Act'), made an application to certify the *South Burnett Regional Council Certified Agreement Field Staff 2025* ('the agreement').
- [2] In addition to the Applicant, the following employee organisations are listed as parties to the agreement:
 - Automotive, Metals, Engineering, Printing and Kindred Industries Industrial Union of Employees, Queensland
 - Construction, Forestry, Mining & Energy, Industrial Union of Employees, Queensland
 - The Australian Workers' Union of Employees, Queensland
 - Transport Workers' Union of Australia, Union of Employees (Queensland Branch)
- [3] The agreement is signed by all the above-mentioned parties. Consequently, I am satisfied that upon certification, pursuant to s 189(2) of the IR Act, the agreement will cover all parties.
- [4] Having regard to the submissions made by the parties who appeared today and to the Affidavit of Mr Mark Pitt filed on 15 July 2025:
 - I am satisfied of each relevant requirement in ch 4, pt 5, div 2, sub-div 2 of the Act; and

- There is nothing in the agreement which would require me to refuse to grant the application pursuant to ch 4, pt 5, div 2, sub-div 3 of the Act.
- [5] The application to certify the agreement is granted.
- [6] The *South Burnett Regional Council Certified Agreement Field Staff 2025* operates from the first pay period on or after the date of certification per Clause 5 of the agreement, namely 20 August 2025.
- [7] Although the nominal expiry date of the agreement is 1 January 2028, it continues to operate until it is terminated under the Act.
- [8] I make the following order:

The South Burnett Regional Council Certified Agreement – Field Staff 2025 is certified.
