**AGRICULTURAL COLLEGES OF QUEENSLAND
(EXCLUDING DOMESTIC AND GENERAL STAFF) AWARD - STATE 2004**

(Gazette, 5 November 2004)

PURSUANT to the Declaration of the Commission as to a General Ruling made on 21 August 2009, the said Award is amended as follows as from 1 September 2009:

1. By deleting clause 5.1.2(a) and inserting the following in lieu thereof:

5.1.2 *Instructors*

(a) The following scale of minimum salaries will apply to employees appointed as Instructors:

2. By deleting clause 5.1.3(a) and inserting the following in lieu thereof:

5.1.3 *Advanced Skills Instructor*

(a) Subject to meeting the following criteria, an Instructor may progress and be appointed as an Advanced Skills Instructor. An Advanced Skills Instructor will be paid a salary of \$2,196.20 per fortnight.

3. By deleting clause 5.1.4(a) and inserting the following in lieu thereof:

5.1.4 *Head of Section*

(a) Subject to the needs of each College, positions of Head of Section may be established. Heads of Section will be paid a fortnightly salary as follows:

4. By deleting clause 5.1.5 and inserting the following in lieu thereof:

5.1.5 The rates of pay in clauses 5.1.2, 5.1.3 and 5.1.4 are intended to include the arbitrated wage adjustment payable under the 1 September 2009 Declaration of General Ruling and earlier Safety Net Adjustments and arbitrated wage adjustments. This arbitrated wage adjustment may be offset against any equivalent amount in rates of pay received by employees whose wages and conditions of employment are regulated by this Award which are above the wage rates prescribed in the Award. Such payments include wages payable pursuant to certified agreements, currently operating enterprise flexibility agreements, Queensland workplace agreements, award amendments to give effect to enterprise agreements and overaward arrangements. Absorption which is contrary to the terms of an agreement is not required.

Increases made under previous State Wage Cases or under the current Statement of Principles, excepting those resulting from enterprise agreements, are not to be used to offset arbitrated wage adjustments.

5. By deleting Schedule 1 and inserting the following in lieu thereof:
