(Supermarkets located in the Gold Coast Coastal Tourist Area (as defined) are deemed to be non-exempt shops wherein the majority of retail floor and shelf space is used for the sale of food products including fruit and vegetables, packaged groceries, dry food goods and/or packaged foods, frozen foods, delicatessen items, uncooked packaged meats, cooked chickens, dairy products, bakery products, takeaway food and prepared food items, confectionery and soft drinks.) Provided that the allowable trading hours for non-exempt stores within the Australia Fair Shopping Centre located in the Gold Coast Coastal Tourist Area (as defined) shall be as follows:
