- (32) Toowong Retail Precinct:

- 3. By inserting a new clause (40) in Schedule 1 (Definitions) as follows:
- (40) The Toowong Retail Precinct The area within the following boundaries:

Commencing at the intersection of Bennett Street and Lissner Street; from that point in a straight line to the intersection of Coronation Drive and Archer Street; thence along Coronation Drive and Benson Street to its intersection with High Street; thence along High Street to its intersection with Jephson Street; thence along Jephson Street to its intersection with Lissner Street; thence along Lissner Street to the point of commencement:

Provided that where the boundary of the Toowong Retail Precinct is a street or drive, shops on both sides of the street or drive shall be regarded as being within the boundary.
