#### **AMENDMENT**

This matter coming on for hearing before the Commission at Brisbane on 25 September and 25 October 2013 this Commission orders that the said Award be amended as follows as from 1 October 2013:

- 1. By deleting clause 1.3.3(1) and inserting the following in lieu thereof:
- (1) Motoring Services Award South-Eastern District 2003 (see Schedule 2 and Section 11 of Schedule 3):
  - Car fitter
  - Car park officer
  - Garage attendant
  - Tyre fitter.
- 2. By inserting into clause 1.3.3 a new subclause (n) as follows:
- (n) Community Police (Aboriginal and Island Communities and Local Governments) Award State 2012 (see Schedule 2 and Section 13 of Schedule 3):
  - \* Community Police Officer-In-Charge (with 9 or more employees)
  - \* Community Police Officer-In-Charge (with less than 9 employees)
  - \* Community Police Officer Grade 1
  - \* Community Police Officer.
- 3. By deleting clause 6.2.4 and inserting the following in lieu thereof:
- 6.2.4 The provisions of clause 6.2 shall not apply to employees covered by Sections 1 and 13 of Schedule 3.
- 4. By deleting clause 6.5.1 and inserting the following in lieu thereof:
- 6.5.1 The provisions below of clause 6.5 do not apply to employees covered by Sections 1 and 13 of Schedule 3 or sections 6, 7, 8, 9 and 11 of Schedule 5.
- 5. By deleting clause 6.6.1 and inserting the following in lieu thereof:
- 6.6.1 The provisions of clause 6.6 do not apply to employees covered by Sections 1 and 13 of Schedule 3, except where otherwise provided for in Schedule 3.
- 6. In Schedule 1:

- (1) The ordinary working hours shall be an average of 38 hours per week and shall not exceed 152 hours within a work cycle not exceeding 28 consecutive days. Such ordinary hours shall be determined by the Queensland Police Service after consultation with the employees concerned.
- (2) Shift work may be worked in accordance with a roster determined by the Queensland Police Service.
- (3) Where a shift is an afternoon or night shift as defined at clause 6.6.2 of this Award, shift allowances in accordance with the provisions of clause 6.6.6 shall apply.

- 9. By inserting a new provision (6) in Schedule 4 (Other Payments For Week-End Work), as follows:
- (6) Community Police (Aboriginal and Island Communities and Local Governments) Award State 2012
  - \* Between midnight Friday and midnight Sunday at the rate of time and-a half.
