This arbitrated wage adjustment may be offset against any equivalent amount in rates of pay received by employees whose wages and conditions of employment are regulated by this Award which are above the wage rates prescribed in the Award. Such payments include wages payable pursuant to certified agreements, currently operating enterprise flexibility agreements, Queensland workplace agreements, award amendments to give effect to enterprise agreements and overaward arrangements. Absorption which is contrary to the terms of an agreement is not required.

Increases made under previous State Wage Cases or under the current Statement of Principles, excepting those resulting from enterprise agreements, are not to be used to offset arbitrated wage adjustments.

2. By deleting clause 2.1 of Section 2 of Schedule D and inserting the following in lieu thereof:

2.1 Salaries

2.1.1 The basis of salaries paid to Electorate Officers shall be as per the rates applicable to the Administrative Stream, between Level 3, Paypoints 3 and 4 and Level 5, Paypoint 4 of the Award.
