# **PORT AUTHORITIES AWARD - STATE 2003**

PURSUANT to the Declaration of the Commission as to a General Ruling made on 21 August 2009, the said Award is amended as follows as from 1 September 2009:

# 1. By deleting clause 5.2.1 and inserting the following in lieu thereof:
