AMENDMENT

This matter coming on for hearing before the Commission at Brisbane on 29 August 2011 this Commission orders that the said Award be amended as follows as from 29 August 2011:

By deleting clause 5.3.1, 5.3.2, 5.3.3 and 5.3.4 and inserting the following in lieu thereof:

5.3.1 The following salaries shall be the fortnightly base rates payable for classifications Firefighter and Station Officer in the Eastern District of the Southern Division:

Firefighter	1,622.90
Firefighter 1 <sup>st</sup> Class	1,744.70
Senior Firefighter	1,841.60
Leading Firefighter	1,958.70
Station Officer 1	2,135.20

Station Officer 3	2,282.90

5.3.2 The following salaries shall be the fortnightly rate payable for classifications Inspector, Superintendent and Chief Superintendent in the Eastern District of the Southern Division and shall be paid for all purposes of the Award:

Inspector	3,731.40
Superintendent	4,073.40
Chief Superintendent	4,293.40

5.3.3 The following salaries shall be the fortnightly base rates payable for classification levels BAO1 and BAO2 in the Eastern District of the Southern Division:

Classification	Per Fortnight \$
BAO1	2,541.90

2,625.10

- 5.3.4 The rates of pay in this Award incorporate adjustments based upon the *Queensland Fire and Rescue Service - Certified Agreement 2006* [CA/2006/277] and include the arbitrated wage adjustment payable under the 1 September 2010 Declaration of General Ruling and earlier Safety Net Adjustments and arbitrated wage adjustments. This arbitrated wage adjustment may be offset against any equivalent amount in rates of pay received by employees whose wages and conditions of employment are regulated by this Award which are above the wage rates prescribed in the Award. Such payments include wages payable pursuant to certified agreements, currently operating enterprise flexibility agreements, Queensland workplace agreements, award amendments to give effect to enterprise agreements and overaward arrangements. Absorption which is contrary to the terms of an agreement is not required.

Increases made under previous State wage Cases or under the current Statement of Principles, excepting those resulting from enterprise agreements, are not to be used to offset arbitrated wage adjustments.
