Trading Hours Act 1990
Trading (Allowable Hours) Amendment Act 1994
(amendment of Commission Orders - Section 8.2)

**TRADING HOURS - NON-EXEMPTED SHOPS
SELLING CARAVANS - STATE**

ORDER

1. This Order shall apply to any and every non-exempted shop situated throughout the whole of Queensland in, from, or at which any caravan is or is usually sold whether employees are or are not employed in such shop or shops.

2. For the purposes of this Order, unless the context otherwise indicates or requires, the following terms shall have the meanings respectively assigned to them:-

"Non-Exempted Shop" - As defined in subsection (1) of section 5 of the *Factories and Shops Act 1960-1985*.

"Caravan" - Any vehicle without motor power capable of being attached to a motor vehicle or a tractor and equipped as a caravan for camping or for use as a dwelling.

"Public Holiday" has the meaning given by the *Holidays Act 1983*.

"Closed" - In relation to a non-exempted shop including showrooms from or at which caravans are sold, closed by being locked to the complete exclusion of the public:

Provided that where a non-exempted shop is an open-air display at which caravans are displayed for sale and which cannot be locked to the complete exclusion of the public, such non-exempted shop shall be deemed to be closed when all doors and windows to caravans, showrooms, and offices are locked, or otherwise securely closed to prohibit soliciting the sale of caravans, or the internal display of same and no employee including a salesman normally employed as such but excluding a watchman or caretaker normally employed as such, is on the premises, and where no person is available for the purpose of making or soliciting the sale of caravans.

"Occupier"- As defined in subsection (1) of section 5 of the *Factories and Shops Act 1960-1985*.

Derivatives of any term to which a meaning is assigned by this clause shall have a corresponding meaning.

3. Except as hereafter provided, the trading hours of non-exempted shops from which caravans are sold shall be-

	Opening Time	Closing Time
Monday to Friday	8 a.m.	9 p.m.
Saturday	8 a.m.	6 p.m.

And such shops shall be kept closed on Sundays and holidays.

Provided that the trading hours of non-exempted shops selling caravans and from which shops motor vehicles are also sold shall be:-

	Opening Time	Closing Time
Monday to Friday	8 a.m.	9 p.m.
Saturday	8 a.m.	5 p.m.

And such shops shall be kept closed on Sundays and holidays.

4. Every non-exempted shop from which caravans are sold shall be closed except during the trading hours such shop is permitted to be opened by this Order.

5. Except in relation to the sale of caravans, this Order shall not affect or apply in any way in respect to trading by non-exempted shops where the trading hours of such non-exempted shops are fixed by or under any other Order made pursuant to the provisions of sections 96B or 96C of the *Industrial Conciliation and Arbitration Act 1961-1986*.

6. This Order shall take effect and be operative as from the twenty-sixth day of September, 1967.
